

Corporate & Business Banking Charges for Banking Services

Effective 1 March 2021



ON-BOARDING FEES

A fee will be applied based upon the Bank's assessment of the complexity of the Account and the risk profile of the Client:

a) Clients introduced and administered by approved Trust and Corporate Service providers:

Level 1 £ Nil

Level 2 £1,500, US\$ 2,250 or €2,250 Level 3 £2,500 US\$ 3,750 or €3,750

b) Others

 Level 1
 £1,000, U\$\$ 1,500 or €1,500

 Level 2
 £2,500, U\$\$ 3,750 or €3,750

 Level 3
 £5,000, U\$\$ 7,500 or €7,500

The amount to be applied may be increased or decreased at the Bank's discretion, but if different, will be advised before commencement of the On-boarding process. Fees will be taken shortly after the account is opened.



PAYMENT FEES

Please note that the currency in which fees are charged by Standard Bank for outward payments is based on the currency of the Account being Debited and not the currency of the payment. Any agents' charges, foreign correspondents' charges or other indirect costs incurred in connection with transactions undertaken may be passed on to you in addition to the charges shown below.

Fees are applicable to transactions undertaken on the Bank's Strata Account and Corporate Call Account.

If charges "remitter" is selected when making a payment in Euros payment charges will be increased by €10, £7 or US\$ 10 (or equivalent).



ACCOUNT MAINTENANCE FEES

Corporate Call Account/Strata Account maintenance charge. A fee will be applied based upon the Bank's assessment of the risk profile of the Client.

The amount to be applied may be increased or decreased at the Bank's discretion, but will be advised at the time the relationship is established or prior to any changes. The first charge will normally be applied at the end of the quarter following the quarter in which the Account is opened.

Optimum Account

If the average Credit balance maintained over any quarterly interest period amounts to less than

Fixed Term Deposit Breakage

No withdrawals or transfers are normally permitted during the contract period. Early termination of the contract may be permitted in exceptional circumstances at the Bank's sole and absolute discretion. If the Bank permits early access, you will be charged an administration fee of £250.00 and will be subject to an interest charge equal to the interest payable to you over the remaining term on the amount withdrawn, which may result in you receiving back less than you deposited.

Notice Deposit Breakage

No withdrawals or transfers are normally permitted before or during the notice period. Early access of a notice deposit may be permitted in exceptional circumstances at the Bank's sole and absolute discretion. If the Bank permits early access, you will be charged an administration fee of £250.00 and will be subject to an interest charge equal to the interest payable to you over the remaining term on the amount withdrawn, which may result in you receiving back less than you deposited.
